Waiver & Application for Membership

Liability Provisions

By application for and after approval of membership in the Beaver Lake Sailing Club, Inc. (BLSC), each member, for himself, his heirs, assignees and spouse, specifically assumes any risk inherent in any activity actually existing on the BLSC premises, shore line, and water adjoining the same. The BLSC and its officers assume no liability whatsoever for any accident or resulting injury, whether personal or otherwise, in the operation and maintenance of the BLSC or activities in connection therewith, or for any equipment owned or operated by the BLSC. Each member agrees specifically for himself, his heirs, assignees, and spouse to hold harmless the BLSC and its officers from any and all liability in connection with any and all BLSC activities or use of BLSC equipment or premises. Each member, or applicant for membership will sign this waiver provided by the BLSC. The waiver assumption and indemnification, is to be in force as long as the member is affiliated with BLSC.

Waiver and Conditions

Beaver Lake Sailing Club, Inc. is a not-for-profit corporation. Members of BLSC, with boats on moorings or in slips, will be responsible to report any dock disrepair to the "dock captain". The Board of Directors may at its sole discretion remove any member from the BLSC for violations of the conditions set forth herein, non payment of dues and/or other levied fees, or violation of the articles and by-laws. BLSC Board of Directors may at its sole discretion approve or disapprove membership in the corporation. In consideration of being granted the membership applied for I/We agree as follows:

1. To assume the risk of using all club facilities and agree to make no claim against BLSC for injury to myself or my property.
2. I/We agree to hold BLSC harmless for any damages that may be claimed because of acts performed by me or damages caused by my property whether occurring while standing or being operated by me or someone at my discretion or with my consent.
3. I/We agree to abide by the articles, bylaws, and BLSC rules as now in existence or as may be here in after amended.
4. I/We agree to pay all dues and storage fees promptly when due.
5. If I/We do not pay any storage fees promptly when due, I/We authorize the Board of Directors or its designate to remove the stored property from BLSC property. Such removal shall be without liability to the BLSC. The Board or its designate shall give notice as may be listed in the bylaws.
6. To comply with all Arkansas boating laws, rules, and regulations as may be lawfully adopted by the State of Arkansas from time to time. This shall include the timely registration or licensing of My/Our boat(s) each year. Should I/We fail to register or license My/Our boat(s) as required, the Board or its designate may remove from BLSC property My/Our boat(s) within a 15 days written notice. Such removal shall be without liability on the part of BLSC.
7. Notice, as called for herein, shall be sufficient when mailed certified U.S. mail to the home address of BLSC record. Notice shall be deemed given when mailed.
8. I/We agree to be responsible for any and all damage to BLSC property caused by My/Our boats(s) being improperly tied or secured.
9. I/We hereby grant to the Board of Directors the right to move or relocate My/Our boat(s) in the event of any emergency, or for maintenance or repair of BLSC docks, grounds, or other facilities.
10. This application and the conditions hereof shall continue in effect during the time of My/Our membership in the BLSC.
11. Should any provision of this application be declared illegal or non-enforceable, such declaration shall not affect the remaining provisions.
12. The provisions of this application shall be binding upon the heirs, executors, and administrators of the applicant(s).
13. The provisions of this agreement shall be interpreted under the laws of the State of Arkansas.
14. This application is not assignable.
